2. All employees of the health sector not to use annual leave, paid and unpaid leave, during this period.
3. The Institute of Public Health is obliged to prepare a text / message for the written and electronic media regarding the observance of the recommendations against COVID-19, and to be submitted to the Ministry of Health, for further processing and publication.
4. The Ministry of Health is obliged to convert the phone number of ALO DOKTORE from the flyer into a call center with increased capacity that will provide answers / information about the disease COVID-19 (corona virus).
5. It is recommended to PE Macedonian Radio - Television, on a regular, daily basis, through television channels, as well as the Parliamentary Channel to publish all conclusions, measures and recommendations adopted by the Government of the Republic of Northern Macedonia for prevention of COVID-19 disease spread. (corona virus), as well as press conferences on the subject.
6. AD MIA - Skopje is instructed to publish on a daily basis all conclusions, measures and recommendations adopted by the Government of the Republic of Northern Macedonia for the prevention of the spread of the disease COVID-19 (corona virus), as well as press conferences. on this topic.
7. All state administration bodies, state-owned public enterprises, state-owned joint stock companies, agencies, funds, bureaus, institutes, administrations and all other state institutions are indebted, and the local self-government units in the Republic of Northern Macedonia are indicated. public enterprises and other legal entities established by the local self-government units, as well as recommended to the private sector, for the employees in these institutions and companies that use justified absence in accordance with the adopted conclusions, measures and recommendations of the Government, to the competent organizational units for human resources in their institutions to request from these persons to submit proof / confirmation for the basis of use of this justified absence, (certificate issued by the kindergarten or a payment slip for paid residence fee in the kindergarten, a copy of the passport for the age of the child or a copy of the birth certificate, a certificate for a regular student from the educational institutions or a copy of the certificate).
8. All bodies of the state administration, public enterprises established by the state, joint stock companies in state ownership, agencies, funds, bureaus, institutes, administrations and all other state institutions are indebted, and the local self-government units in the Republic of Northern Macedonia are indicated. public enterprises and other legal entities established by the local self-government units, as well as recommended to the private sector, for the employees in these institutions and companies who have a minor child up to 10 years of age or actively fourth grade for whom home care is necessary. one parent to be released from work and work activities and his absence during this period to be recorded as justified by the employer.
This conclusion also applies to single parents.
Additionally, children who do not attend kindergarten or are not institutionally involved in the educational process, the parents of these children are not exempt from work and performing work activities.
9. All bodies of the state administration, state-owned public enterprises, state-owned joint stock companies, agencies, funds, bureaus, institutes, administrations and all other state institutions are indebted, and the local self-government units in the Republic of Northern Macedonia are indicated. public enterprises and other legal entities established by the local self-government units, as well as recommended to the private sector, for the employees in these institutions and companies that use justified absence in accordance with the adopted conclusions, measures and recommendations of the Government, to the competent organizational units for human resources in their institutions to submit their personal written statement under the moral, material and criminal responsibility that at any time they will be available to the employer to perform official work duties and obligations from their home, by communicating by e-mail, or during the day in emergency situations to be physically at work, for a period of two to three hours (form Statement submitted in support of this conclusion).
10. The Ministry of Interior is obliged to strengthen the controls at the border crossings at the exit from the Republic of Northern Macedonia, especially the control of the bus transport and the destination.
11. All educational institutions to introduce rotational duty, in order to issue the necessary certificates and other documents.
12. To stop the work of the libraries, the student dormitories and the student dormitories on the territory of the Republic of Northern Macedonia, in the next 14 days, and the employees in these institutions to be fired during this period.
13. Employees of the Ministry of Interior, Ministry of Health, Ministry of Defense, Army of the Republic of Northern Macedonia, fire territorial units, Customs Administration, as well as nursing homes and small group homes to be exempted from all conclusions, government measures and recommendations.
14. The Ministry of Interior is obliged to publish a statement today stating that appropriate measures will be taken for all those persons who publish disinformation (untruths) on this topic through social media, as well as for the media that transmit this information.
15. The Government's economic departments are closely monitoring the situation in the economy and the economy through domestic economic and financial institutions, the World Bank and others, and based on the analysis, if necessary, appropriate measures will be taken.
16. The recommendation to the private sector regarding all adopted conclusions, measures and recommendations from the Government for the current situation is sent again.
17. The Ministry of Health, through the Centers for Public Health and in cooperation with the local self-government units, is obliged to disinfect all kindergartens and schools on the territory of the Republic of Northern Macedonia.
18. The Public Relations Department of the Government of the Republic of Northern Macedonia undertakes to immediately publish these conclusions, measures and recommendations on the Government's website and to submit them to all written and electronic media, in order to regularly inform the citizens. Regular information on this topic will be provided through the Public Relations Department of the Government of the Republic of Northern Macedonia

In addition, we present to you all the additional conclusions, measures and recommendations from the 16th session of the Government of the Republic of Northern Macedonia:

1. The following categories of persons who should be dismissed from work and work activities are determined on the basis of an attached certificate from a family doctor for the following conditions:

- Chronic respiratory diseases;
- Severe cardiovascular disease;
- Diabetes - TYPE 1;
- Malignant diseases; and
- Immuno-compromising conditions.

Accordingly, the Ministry of Health and the Commission on Infectious Diseases are obliged to prepare and submit a list of diagnoses regarding the above-mentioned
