From the 17th session of the Government: A Decision on measures to prevent the introduction and spread of Coronavirus COVID-19 was adopted, by which all its measures get a legal basis for their implementation.

- Intermittent hemodialysis - Z99.2
- Conditions with biological or combined immunomodulatory therapy - M05, M06, M45.00
- Necrotizing vasculopathy, systemic lupus erythematosus, systemic lupus erythematosus, systemic sclerosis - M31 - M34.

2. To stop working and to close cinemas, theaters, playgrounds and museums and all other institutions where mass gatherings, events or concerts and other cultural-informational events can be held, ie a complete ban on holding and organizing any type of public private gatherings, regardless of the volume and number of participants during this period.

3. To stop working and to close all sports facilities or gyms, where all kinds of gatherings and events can be held, regardless of the volume and number of participants during this period.

4. Catering facilities, cafes, bars, restaurants, clubs, casinos and sports betting to work part-time, from 7.00 am to 6.00 pm, with half capacity for guests, ie to maintain a minimum necessary distance of at least one meter and a half up to two meters between the people staying in these facilities.

5. To prohibit the entry into the territory of the Republic of Northern Macedonia of foreign citizens from high risk countries in accordance with the List of the World Health Organization published on the website of the Ministry of Health, except those who will submit a certificate issued by a competent authority for quarantine.

6. To implement recommendations for punishment in accordance with Articles 205 and 206 of the Criminal Code for all natural and legal persons who

violate the decisions made by the State Sanitary and Health Inspectorate and to process them to the Public Prosecutor's Office of the Republic of Northern Macedonia to act in accordance with its legally established competencies.

7. Having in mind that the border crossing "Fishermen" in the Republic of Serbia from today, March 12, 2020 (Thursday), from 7.00 am, is closed for crossing for passengers and vehicles in accordance with the guidelines of the Government of the Republic of Serbia, all passengers and vehicles from the border crossing "Golema Crkovijska" - Golesh (Kriva Palanka) in the Republic of Northern Macedonia to be redirected to the border crossings that are open for free flow of passengers and vehicles.

8. Having in mind that the border crossing Prohor Pchinski from March 12, 2020 (Thursday) at 7.00 am, is closed for passage for passengers and vehicles in accordance with the guidelines of the Government of the Republic of Serbia, all passengers and vehicles from the border crossing Pelince in the Republic of Northern Macedonia to be redirected to the joint border crossing with the Republic of Serbia, Tabanovce - Presevo.

9. For all chronically ill patients whose surgery was previously scheduled and there is a possibility to postpone, ie to perform only urgent emergency surgery, especially oncology.

10. Regarding the continuation of the therapy of the chronically ill patients who until now should have gone to a specialist doctor, in the following days to turn to their family doctors.

This measure does not apply to newly diagnosed patients.

11. Regarding the new situation and the local transmission with the spread of COVID-19 disease on the territory of the municipalities of Debar and Centar Zupa, the Ministry of Health, in cooperation with the centers for public health, undertakes to take additional measures to prevent the spread of this virus, ie to mobilize the medical teams with an epidemiologist from Ohrid and an infectious disease specialist or a doctor (or the infectious disease specialist who is employed in the bathrooms Capa to be put into service for the needs of the public health centers).

A report on these measures should be submitted by the end of today, in order for the Ministry of Health to publish a preventive statement on the territory of the municipalities of Debar and Centar Zupa, on the possibility of introducing quarantine.

12. To terminate the specialization of all state trainees and subspecialists employed in the Health Center Skopje, for a period of 14 days and to return them to their jobs in the home institution.

13. The Ministry of Health, in cooperation with the public health institutions, is obliged to immediately increase the capacity for the needs of the Home Visiting Service and to include in it the general practitioners who work under mentorship.

14. The Ministry of Information Society and Administration, in cooperation with the Ministry of Health and the telephone and mobile operators, is obliged to consider the possibility of sending a circular message through mobile applications (SMS, Viber message, etc.), with recommendations especially to the younger population, to respect the conclusions, measures and recommendations regarding the prevention and spread of COVID-19.

For this purpose, consider the possibility of using the existing mobile application MY VAT.

15. AD M-NAV Skopje and the Ministry of Health are obliged to undertake the following activities for informing the participants in the air traffic, for the measures and activities for prevention of the spread of the disease COVID-19 (corona virus):

15.1. AD M-NAV Skopje is obliged to issue the following NOTAM messages:

- NOTAM 1 - The airlines, through their crew - are obliged during their flights to collect PLF (Passenger Locator Form) forms from passengers, to review them and hand them over to their agent upon arrival in the Republic of Northern Macedonia.

The authorized agent of the airline is obliged to submit the PLF (Passenger Locator Form) forms from the passengers to the Emergency Medical Service of the airport TAV DOOEL Macedonia - Skopje International Airport and to the medical service of the Airport "St. Apostle Paul" - Ohrid, in charge of monitoring the measures and activities for prevention of the spread of COVID-19 (corona virus).

All passengers, crew members and operational personnel must fill out the PFL form upon arrival by plane in the Republic of Northern Macedonia.

All PFL templates must be collected by the crew, checked and numbered and submitted to the agent immediately after landing.

- NOTAM 2 - The airlines, after previously received information from the competent services of the Republic of Northern Macedonia, in charge of monitoring the measures and activities for prevention of the spread of the disease COVID-19 (corona virus), are obliged to inform the passengers before boarding. the precautionary measures in force upon entry into the Republic of Northern Macedonia, in accordance with the current situation and the measures taken and the activities for prevention of the spread of the disease COVID-19 (coronavirus), proposed by the Ministry of Health.

- all airlines arriving in the Republic of Northern Macedonia, to inform their passengers, before entering the aircraft, about the following:

- a) all foreign citizens entering the Republic of Northern Macedonia, who have visited the following countries / territories in the last 14 days:

(List of countries for which the undertaken measure will be valid - the list will be renewed on a daily basis and it will be submitted to AD M-NAV Skopje (section Notam) by the Ministry of Health, to the e-mail address: notam@mnavigation.mk (<mailto:notam@mnavigation.mk>)), will be subject to mandatory 14-day self-isolation.

- b) all foreign nationals who do not have a regular residence in the Republic of Northern Macedonia, must have proof of reserved accommodation.

This obligation will be subject to modification depending on the further development of the situation.

c) all citizens of the Republic of Northern Macedonia, who in the last 14 days have visited the following countries / territories:

(list of countries for which the measure will be valid - the list will be renewed on a daily basis and it will be submitted to AD M-NAV Skopje (section Notam) by the Ministry of Health, to the e-mail address: notam@mnavigation.mk (mailto:notam@mnavigation.mk)),

will be subject to mandatory 14-day self-isolation.

This 14-day period will be considered from the last day of stay in the country / territory at risk, according to the list of countries of the World Health Organization.

16. The Ministry of Health is obliged to regularly, on a daily basis, submit a list of countries for which the measures and activities for prevention of the spread of COVID-19 disease (coronavirus) to AD M-NAV Skopje will apply.

17. The Ministry of Health is obliged to immediately inform the Civil Aviation Agency about these conclusions, measures and recommendations of the Government.

18. It is recommended to PE Macedonian Radio Television, on a regular basis, on a daily basis to allocate space for educational program intended for preschool children and primary school students which will be prepared by the Ministry of Education and Science and the Bureau for Development of education, in cooperation with the educational staff of kindergartens and schools, the Ministry of Labor and Social Policy, UNICEF and all relevant educational institutions.

For this purpose, the Ministry of Education and Science - Bureau for Development of Education, as soon as possible to prepare an intervention educational program in the languages covered in the educational process and in cooperation with PE Macedonian Radio Television to broadcast it on a daily basis. .

The Ministry of Education and Science is also obliged to share the educational materials on all social networks and channels.

19. To appeal to the citizens of our country living in high and medium risk countries to postpone their arrival in the country during this period.

20. All Ministries are obliged to form their own teams, to designate a special e-mail and telephone line which will provide information regarding the administrative issues related to the implementation of the recommendations and measures for dealing with the COVID-19 coronavirus and the data from the formed team. and submit the contact details to the Public Relations Department of the Government, which will publish them on the website of the Government of the Republic of Northern Macedonia.

21. The Ministry of Economy, the Ministry of Labor and Social Policy, the Ministry of Transport and Communications, the Ministry of Finance, the Public Revenue Office and the Customs Administration are obliged to nominate persons for contact with the chambers of commerce (for communication with the real sector) and who to be submitted to the Chambers of Commerce, in order to receive the conclusions from the Government sessions on a regular basis and to respond in a timely manner to the questions raised regarding the implementation of the recommendations and measures for dealing with the COVID-19 coronavirus.

22. All conclusions, measures and recommendations adopted by the Government of the Republic of Northern Macedonia to be submitted to all ministries, in order to publish them on their websites.

23. The Ministry of Health is obliged to translate all materials related to the prevention of the spread of coronavirus COVID-19 into Albanian.

24. The Ministry of Foreign Affairs is obliged, through diplomatic and consular missions of the Republic of Northern Macedonia, to inform our citizens abroad about high-risk countries, in accordance with the List of the World Health Organization.

25. Reviewed the Request of the Pension and Disability Insurance Fund of Northern Macedonia for realization of the Spa Climate Recreation Project for 2020 and concluded that the realization and implementation of the first group of the Project to be postponed.

26. The Public Relations Department of the Government of the Republic of Northern Macedonia is obliged to immediately publish these conclusions, measures and recommendations on the website of the Government and to submit them to all print and electronic media, in order to regularly inform the citizens.

Having in mind the above, in order to order measures to prevent the introduction and spread of coronavirus COVID-19, and in order to ensure the protection of the health of the population on the territory of the Republic of Northern Macedonia, the Government adopted a Decision based on Article 58 paragraph (1) of the Law on Protection of the Population from Infectious Diseases ("Official Gazette of the Republic of Macedonia" No. 66/04, 139/08, 99/09, 149/14, 150/15 and 37/16),

This decision covers all measures to prevent the introduction and spread of coronavirus COVID-19 adopted at all sessions of the Government which thus provide a legal basis for their implementation.

DECISION

for measures to prevent the introduction and spread of Coronavirus COVID-19

Article 1

With this decision, in order to prevent the introduction and spread of the possibility of infection by Coronavirus COVID-19, and in order to ensure protection of the health of the population on the territory of the Republic of Northern Macedonia, the following measures are ordered:

1. The educational process and teaching in all kindergartens, centers for early childhood development, day care centers, primary and secondary schools is

prohibited.

2. It is forbidden to hold classes in higher education institutions and public scientific institutions.
3. Disrupt student dormitories, libraries, theaters, cinemas, museums, and playgrounds.
4. It is forbidden to visit all extracurricular activities and other private activities that children perform outside of classes (visit of educational activities, courses, additional classes, sports trainings, etc.).
5. It is forbidden to hold and collect mass gatherings and events in open and closed space, any kind of public and private gatherings, as well as all cultural, informative, sports events and manifestations, regardless of the volume and number of participants, in public buildings and others. public places (cinemas, theaters, museums, libraries, sports facilities, sports and children's playgrounds).
6. All sports facilities, gyms, sports halls are closed where all kinds of gatherings and events can be held, regardless of the volume and number of participants.
7. It is forbidden to hold all sports events and competitions before the presence of spectators (audience).
8. The use of any type of swimming pools on the territory of the Republic of Northern Macedonia is prohibited.
9. It is forbidden to work on catering facilities, cafeterias, bars, restaurants, clubs, casinos, sports betting shops, from 18.00 to 7.00 the next day and to work with halved guest capacity, ie to keep a minimum necessary distance of at least one meter and half to two meters between the people staying in these buildings.
10. It is prohibited for all state administration bodies, state-owned public enterprises, state-owned joint stock companies, agencies, funds, bureaus, offices, administrations and all other state institutions, and refers to the units of local self-government in the Republic of Northern Macedonia, public enterprises and other legal entities established by local self-government units, as well as recommended to the private sector, holding events, trips, gatherings, trainings, seminars, conferences and other types of meetings and cancel them.
11. The use of vacations, paid and unpaid leave by all employees in the health sector is prohibited, and the specialization of all state trainees and subspecialists employed in the Health Center Skopje is terminated and they return to their jobs in the home institution.
12. It prohibits economic operators and producers from the Republic of Northern Macedonia, export of medical equipment and medical supplies and materials, required for dealing with Coronavirus COVID-19, except for those for whom a special permit has been issued by the Ministry of Health.
13. Organized international bus transportation (bus, van, minibus, etc.) to high-risk countries in accordance with the World Health Organization List, as well as from those countries to the Republic of Northern Macedonia, is prohibited.
14. To prohibit the entry of foreign nationals from high-risk countries, according to the List of the World Health Organization published on the website of the Ministry of Health on the link: zdravstvo.gov.mk/wp-content/uploads/2020/03/Spisok-na-zemji11.03.2020.pdf, (hereinafter: the List of the World Health Organization), except those who will submit a certificate issued by a competent authority for quarantine.
15. In case of occurrence of passengers at the border crossings of the Republic of Northern Macedonia from countries with high and medium risk according to the List of the World Health Organization, they must conduct self-isolation.

Article 2

The measures referred to in Article 1 of this Decision shall apply until March 24, 2020, except for measure 7, which shall apply for 30 days from the date of entry into force of this Decision.

For the time period referred to in paragraph 1 of this Article, other measures, recommendations and guidelines adopted by the Government of the Republic of Northern Macedonia at the proposal of the competent authorities of the State Administration and other coordination and professional bodies regarding the prevention of the spread of Coronavirus COVID shall be observed. 19.

Article 3

This Decision shall enter into force on the day following the day of its publication in the "Official Gazette of the Republic of Northern Macedonia", ie on March 13, 2020.
