Pursuant to Article 2 of the Decree on Measures during the State of Emergency ("Official Gazette of RS", No. 31/20) and Article 15, paragraph 1 of the Law on State Administration ("Official Gazette of RS", No. 79/05, 101/07 and 95/10, 99/14, 30/18 - other law, 47/18),

The Minister of the Interior, with the consent of the Minister of Health, makes

## **ORDER**

## on restriction and prohibition of movement of persons on the territory of the Republic of Serbia

"Official Gazette of RS", no. 34 of 18 March 2020, 39 of 21 March 2020, 40 of 22 March 2020, 46 of 28 March 2020, 50 of 3 April 2020.

- 1. In order to suppress and prevent the spread of the infectious disease Covid-19 and protect the population from that disease, movement in public places, ie outside apartments, rooms and residential buildings in residential buildings and outside the household (garden), is prohibited, as follows:
  - 1) persons over 65 years of age or older in populated areas over 5000 inhabitants;
  - 2) persons over 70 years of age or older in populated areas up to 5000 inhabitants.

The prohibition referred to in paragraph 1 of this item does not apply to the period \* on Saturdays, from 04:00 to 07:00 \*\*.\*

- 2. It is forbidden for all persons to go out of apartments, rooms and facilities for living in residential buildings and outside the household (garden), from **5 pm\*** to 5 am on **working days, as well as from 1 pm on Saturdays to 5 am on Mondays\*\***.

The previous paragraph 2 has been deleted (see point 1 of the Order - 46 / 2020-3)

Notwithstanding paragraph 1 of this item, it is allowed to take pets in the period from 11 pm to 1 am the next day, as well as on Sundays in the period from 8 am to 10 am, for 20 minutes, up to a maximum of 200 m from the place of residence, that is, residence, starting from April 4, 2020.\*\*

At a time when in accordance with Art. 1 and 2 of this point, the exit of persons is allowed, it is prohibited for more than two persons to move together or stay in a public place in the open.\*\*

The prohibition referred to in paragraph 3 of this item does not apply to parents with minor children.\*\*

2a It is prohibited to move in all parks and public areas intended for recreation and sports, starting from March 21, 2020, at 8 p.m.\*

- 3. Prohibition from point. 1 and 2 of this order does not apply to:
- 1) health workers with a license;
- 2) members of the Ministry of the Interior, the Ministry of Defense, the security services and the Serbian Army, who are on assignment;
  - 3) persons to whom the Ministry of the Interior issues a movement permit.

3a During the funeral, the presence of more than 10 people is prohibited, with the obligatory respect of the distance between those present of 2 meters.\*

- 4. Prohibition from point. 1 and 2 of this order do not apply to natural persons who urgently need medical assistance and a maximum of two persons accompanied by that person.

4a Prohibition from item 1 and 2 of this order does not apply to domestic and foreign nationals who are members of the crew of freight motor vehicles, cargo ships, railway staff, crews and cabin crew of aircraft, which perform international transport by road, rail, water and air. traffic.\*

Non-compliance with the prohibition from points. 1 and 2 of this order shall be punished for a criminal offense in accordance with the Criminal Code, and for a misdemeanor in accordance with the Decree on Misdemeanor for violation of the Order of the Minister of Internal Affairs on Restriction and Prohibition of Movement of Persons in the Republic of Serbia.\*
