Application of measures of emergency situation

Due to the emergency situation declared by the Government of the Republic Order No. 76 "Declaration of an emergency situation in the administrative territory of the Republic of Estonia" of 12 March 2020, the Government of the Republic decides:

- 1. Under§ 31 (1) and (3) of the Emergency Act, a restriction on the freedomof movement is imposed in educational establishments in order to suspendregular studies in educational institutions as of 16 March 2020 and tointroduce distance learning, including:

 1) relevant internal information sessions shall be promptly held in all basic schools, upper secondary schools,
- 1) relevant internal information sessions shall be promptly held in all basic schools, upper secondary schools, vocational educational institutions and institutions of higher education and pupils and students shall be given all study materials necessary for distance learning;
- 2) the Government of the Republic or the person in charge of emergency situation shall make a separate decision concerning measures to be applied in respect of studies of students with special educational needs;
- 3) whether preschools and childcare establishments are open and their organisation of work shall be decided by the managers thereof;
- 4) recreational activities and provision of hobby education shall be suspended, unless these are possible through distance learning, and the activities of youth centres and youth camps shall be suspended, and the organisation of training of drivers of power-driven vehicles, driver training and training of drivers carrying dangerous goods shall be suspended, unless this is possible through distance learning or by using a simulator or means that allow keeping of distance or if training of drivers of power-driven vehicles, driver training, training of drivers carrying dangerous goods or emergency vehicle driver training is provided to a serviceman or if emergency vehicle driver training is provided to a police officer, a rescue servant, an assistant police officer or a voluntary rescuer; [RT III, 10.04.2020, 3 entry into force 09.04.2020]
- 5) the measures referred to in sub-clauses 1) through 4) shall apply until this Order is changed and the need for these measures shall be assessed no later than after every two weeks.
- **2.** Therestriction provided for in clause 1 does not apply to research anddevelopment activities in universities and research institutions.
- **3.** Under§ 32 (1) of the Emergency Act, all public gatherings, filmscreenings, night clubs, shows/performances, concerts and conferences and sports and exercise events are prohibited from 13 March 2020 and under§ 31 (1) of the Emergency Act, visiting museums and other exhibitions is prohibited. - 3¹. The restriction provided for in clause 3 does not applyto outdoor sports and exercise events provided there are no more than tenparticipants in a group and the restrictions on the freedom of movementprovided for in clause 1 of the Prime Minister's Order No. 45 of 24 March 2020 are complied with and the organisers of such sports and exercise events ensure the availability of disinfectants. Outdoor training of championship league teams in team sports and candidates for Estonian adultsports teams is allowed, taking into account the international competitionrules for the sport, and in that case the restrictions on the maximum size of agroup provided for in

the first sentence of this clause and the restrictionsprovided for in clause 1 of the Prime Minister's Order No. 45 of 24 March 2020 are not applied.

- 3². The restriction provided for in clause 3 does not applyto visiting museums and other exhibitions, provided the following requirements are met:
- 1) the restrictions on the freedom of movement provided for in clause 1 of the Prime Minister's Order No. 45 of 24 March 2020 are complied with;
- 2) in the case of group visits there may be no more than ten visitors in a group;
- 3) the service provider has ensured the availability of disinfectants;
- 4) in rooms open for the public, the service provider has ensured wet cleaning of surfaces subject to frequent touching after every 2 to 4 hours;
- 5) interactive displays are closed or the service provider has ensured their wet cleaning after each use or the service provider has made disposable gloves available to the visitors and has ensured the safe handling thereof after use:
- 6) the service provider does not hand out free physical information materials;
- 7) the service provider does not organise creative work or workshops with shared means of work.

- 3³. The restriction provided for in clause 1 does not apply to basic schools, upper secondary schools, vocationaleducational institutions and institutions of higher education or to theorganisation of the activities of institutions providing refresher training, recreational activities and hobby education and the activities of youthcentres, provided the following requirements are met:
- 1) there are up to ten persons in a study group, except for examinations, state examinations and professional examinations;
- 2) students taking an examination, a state examination or a professional examination are scattered in the examination room, taking into account the restrictions on the freedom of movement provided for in clause 1 of the Prime Minister's Order No. 45 of 24 March 2020;
- 3) movements of groups of students in the building of the relevant educational institution and in the territory used for the provision of education are scattered;
- 4) shared items in the building of the relevant educational institution and in the territory used for the provision of education are disinfected after use.

- 3⁴. Therestriction provided for in sub-clause 4) of clause 1 does not applyto the organisation of driving instruction within training of drivers of power-driven vehicles, driver training and training of drivers carrying dangerous goods, provided the following requirements are met:
- 1) only the instructor and learner are in the vehicle and neither of them show any symptoms of the coronavirus causing the COVID-19 disease;
- 2) the availability of disinfectants must be ensured in the vehicle for driving practice;
- 3) after each driving lesson the organiser of the training organises the cleaning of the surfaces that the learner touched while behind the wheel.

- **3⁵.** Therestriction provided for in clause 1 does not apply to the EstonianAcademy of Security Sciences upon conducting repeat final examinations at thePolice and Border Guard College. Repeat final examinations shall be performed in a scattered manner and every part of the examination shall be taken by up to two students at a time. - **3⁶.** Therestriction provided for in clause 3 does not apply to indoor trainingwith the consent of the Ministry of Culture for athletes who are at leastcandidates for Estonian adult sports teams and if the organiser of the trainingalong with the owner or possessor of the relevant sports site has ensured theavailability of disinfectants. Therestriction provided for in clause 3 does not apply to the conduct of public religious services and other public religious rites provided therestrictions on the freedom of movement provided for in clause 1 of the Prime Minister's Order No. 45 of 24 March 2020 are complied with anothe availability of disinfectants is ensured. - 38. The restriction provided for in clause 3 does not applyto the organisation of open air public events where the visitors are in their cars and do not get out of their cars during the event without an urgent need, provided the following requirements are met:
- 1) there are no more than two visitors per car, except for family members;
- 2) the service provider ensures that the visitors comply with the prohibition not to get out of their car;
- 3) upon organising the parking of cars the service provider ensures an adequate distance between cars;
- 4) the service provider ensures compliance with the restrictions on the freedom of movement provided for in clause 1 of the Prime Minister's Order No. 45 of 24 March 2020.

- **4.** Under§ 31 (3) of the Emergency Act, a restriction on the freedom ofmovement is imposed on passengers concerning going on a ferry sailing on theroute Tallinn–Stockholm–Tallinn for the purpose of a pleasure trip.
- 5. Under § 31 (1) of the Emergency Act, the following restrictions on the freedom of movement are imposed:
- 1) visiting hours in social welfare institutions and hospitals are prohibited;
- 2) visiting hours inpenitentiary institutions are prohibited.
- **5¹.** Supervision over compliance with the requirements for theorganisation of driver training as set out in subclause 4) ofclause 1 and in clause 3⁴ is exercised by the RoadAdministration and the Police and Border Guard Board, and supervision overcompliance with the requirements set out in clauses 3³ and3⁵through 3⁻ is exercised by the Police and BorderGuard Board. Supervision over compliance with the requirements set out inclause 3⁵ is exercised by the Police and Border Guard Board. [RT III, 08.05.2020, 12 entry into force 15.05.2020]
- **6.** Broadcasters and electronic communications undertakings shall publish the Order promptly inunaltered form and free of charge.
- 7. TheOrder takes effect upon signing.

This Order establishes specific measures for the protection of the life and health of people and overriding public interest, said measuresbeing essential for preventing the spread of the virus. The reasons and considerations are set out in the explanatory memorandum to the Order. The explanatory memorandum to the Order will be published on the website of the Government of the Republic.

Failureto duly comply with measures of emergency situation will prompt the application of the administrative coercive measures set out in § 28 (2) or (3) of the Law Enforcement Act.

ThisOrder can be appealed against pursuant to the procedure provided for in theCode of Administrative Court Procedure.
