#### Instrument of Directions to Government Agencies relating to COVID-19 and Tropical Cyclone Harold (Amendment) Order No. 150 of 2020


#### 1 Amendments

## **SCHEDULE**

### **AMENDMENTS OF THE INSTRUMENT OF DIRECTIONS TO GOVERNMENT AGENCIES RELATING TO COVID-19 AND TROPICAL CYCLONE HAROLD ORDER NO.71 OF 2020**

**1 Heading**

Delete "AND TROPICAL CYCLONE HAROLD"

**2 Clause 2**

Repeal the clause.

**3 Paragraph 1(aa)**

Delete "do not enter Vanuatu waters", substitute "enter Vanuatu waters subject to the conditions as may be imposed and supervised by the NDMO and the Ministry of Health"

**4 After paragraph 1(aa)**

Insert

"1(ab) the Ministry of Infrastructure and Public Utilities and the Department of Ports and Harbor must ensure that Port Vila is the only international port of entry for the purposes set out under paragraph 1(aa);"

**5 Paragraph 1(bb)**

Repeal the paragraph, substitute

"1(bb) the Ministry of Infrastructure and Public Utilities and the Department of Ports and Harbor must ensure that Port Vila Bauerfield International Airport and Port Vila are the only international ports of entry for the purposes set out under subparagraphs (ba)(i) and (ba)(ii);"

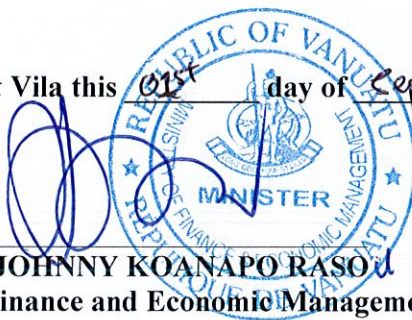
#### 1 Appointment
