Quarantining of high-risk individuals for the control of COVID-19 outbreak

This is to further clarify the contents of my letter dated 08. 04. 2020 with even number on the above subject.

Please note that restrictions imposed on travelling between districts in order to prevent any potential transmission of COVID-19 across the country should remain unchanged until further notice.

However, if any person travels between districts with permission for essential services or for healthcare or any other justifiable reason, such people need not be quarantined. This include those who travelled to districts identified as high-risk for COVID-19. In the meantime, if any person is found to have travelled unauthorized crossing district borders or even within the district from travel restricted areas, such incidents should be carefully assessed for the need for quarantining and appropriate action should be taken and also should be communicated to the Officer-in-charge of the area Police for appropriate action.
