Subject- Tracing of international passengers.

As per the guidelines of Health Department, the Deputy Commissioners were requested to divide the districts in sectors and appoint Sectoral Officers for systematic tracing of passengers who have arrived from abroad from 30.1.2020 onwards.


- 2. The persons traced are required to be quarantined and a poster has to be pasted outside the house. To ensure that the quarantined persons remain indoors, Surveillance Officers were required to be appointed. The Deputy Commissioners are again requested to effectively implement these guidelines.
- 3. To ensure that each and every traced person is quarantined, it is absolutely necessary-
 - (1) That the number of international passengers is ascertained, de-duplicated and frozen. The districts on various occasions were sent the lists of international passengers in a hap-hazard manner. The figure of such international passengers is about 1.06 lakh. The Health Department thereafter, at the headquarters tried to arrange the data in a systematic manner and after de-duplication, the final figure turned out to be 55,669 persons. The district-wise details are enclosed herewith. You may give this data to Sectoral Officers and finalize and freeze this figure after removal of duplicate records.
 - (2) The number of persons, whose figure is frozen as above, are to be tracked/traced and quarantined as per guidelines of Health Department.
 - (3) The persons under quarantine are to be observed from time to time by the surveillance team and if any quarantined person is found to have the symptoms, of Corona then the concerned persons be tested immediately.
