## COVID-19 (TEMPORARY MEASURES) ACT 2020 (ACT 14 OF 2020)

# COVID-19 (TEMPORARY MEASURES) (PERFORMANCES AND OTHER ACTIVITIES — CONTROL ORDER) (AMENDMENT NO. 2) REGULATIONS 2020

In exercise of the powers conferred by section 34(1) of the COVID-19 (Temporary Measures) Act 2020, the Minister for Health makes the following Regulations:

#### Citation and commencement

1. These Regulations are the COVID-19 (Temporary Measures) (Performances and Other Activities — Control Order) (Amendment No. 2) Regulations 2020 and come into operation on 28 December 2020.

# Amendment of regulation 2

- **2.** Regulation 2(1) of the COVID-19 (Temporary Measures) (Performances and Other Activities Control Order) Regulations 2020 (G.N. No. S 927/2020) (called in these Regulations the principal Regulations) is amended
  - (a) by inserting, immediately after the words "or a live performance hirer)" in the definition of "audience member", the words "and includes an individual lawfully present in or around a live performance venue who is attending or watching the live performance (such as busking outdoors)"; and
  - (b) by inserting, immediately after paragraph (b) of the definition of "live performance venue", the following paragraph:

"(c) any place mentioned in regulation 5(2) where a live performance may be approved under regulation 19(1) to take place;".

### Amendment of regulation 5

**3.** Regulation 5(2) of the principal Regulations is amended by inserting, immediately after the words "specified in the Schedule", the words ", or any other outdoor place,".

### Amendment of regulation 13

**4.** Regulation 13(1) of the principal Regulations is amended by deleting "100" in sub-paragraph (a)(i) and substituting "250".

### Amendment of regulation 19

- **5.** Regulation 19 of the principal Regulations is amended
  - (a) by inserting, immediately after the words "in regulation 5(2)" in paragraph (1), the words "or any other outdoor place"; and
  - (b) by deleting the full-stop at the end of sub-paragraph (c) of paragraph (2) and substituting a semi-colon, and by inserting immediately thereafter the following sub-paragraph:
    - "(d) for a live performance in an outdoor place not mentioned in regulation 5(2) —
      - (i) the adequacy of the demarcation and the suitability of the layout of the outdoor place, particularly the manner of access and entrances to and exits from the place and the types of access controls at each entrance and exit (where applicable) —

- (A) for securing compliance, by audience members attending and performers at that live performance, with the requirements of the Main Control Order and these Regulations; and
- (B) for addressing the risk of a large gathering of individuals which may be present for the purpose of transiting through the outdoor place; and
- (ii) the type of live performance and how it may interact with other activities lawfully taking place in the vicinity of that outdoor place, particularly the requirements of the Main Control Order and these Regulations in relation to those activities.".
