CANCELLATION OF EXTRAORDINARY MEASURES

The Ministry of Health, as the competent administrative authority pursuant to Section 80(1)(h) of Act No. 258/2000 Coll., on Public Health Protection and amendments to certain related acts, as amended (hereinafter referred to as "Act No. 258/2000 Coll."), proceeding pursuant to Section 69(1)(i) and (2) in conjunction with Section 94a(4) of Act No. 258/2000 Coll.,

I.

cancels the extraordinary measure of 15 March 2020, Ref. No. MZDR 16195/2020-1/MIN/KAN and the extraordinary measure of 17 April 2020, Ref. No. MZDR 16484/2020-1/MIN/KAN.

II.

This cancellation of the extraordinary measures takes effect at 12:00 a.m. on 24 April 2020.

Rationale:

The extraordinary measure of the Ministry of Health Ref. No. MZDR 16195/2020-1/MIN/KAN of 15 April 2020 prohibited the free movement of persons throughout the Czech Republic, with certain exceptions, effective from 20 April 2020.

The extraordinary measure of the Ministry of Health Ref. No. MZDR 16484/2020-1/MIN/KAN of 17 April 2020 prohibited the free movement of persons throughout the Czech Republic, with certain exceptions, effective from 27 April 2020 and, as at the same date, the extraordinary measure of the Ministry of Health Ref. No. MZDR 16195/2020-1/MIN/KAN of 15 April 2020 was repealed.

Pursuant to Section 94a(4) of Act No. 258/2000 Coll., it applies that if the reasons for issuing the general measure pursuant to subsection (2) were to pass or change, the public health protection authority will immediately cancel or change the measure.

With regard to the ruling of the Municipal Court in Prague of 23 April 2020, Ref. No. 14 A 14/2020, the Government of the Czech Republic decided to adop a crisis measure of similar content on 23 April 2020 through Government Resolution No. 452, published under No. 194/2020 Coll.

With regard to the foregoing, the Ministry of Health has decided to cancel the extraordinary measure of 15 April 2020, Ref. No. 16195/2020-1/MIN/KAN, and the extraordinary measure of 17 April 2020, Ref. No. MZDR 16484/2020-1/MIN/KAN.
