Who is required to go into isolation?

The goal of isolation is to reduce infection and contain the spread of COVID-19 in Israel. Isolation means avoiding contact with other people, including household members for the period specified in the Ministry of Health Director General Order.

Confirmed coronavirus cases and people in isolation (for whatever grounds) are allowed to exit their isolation address to cast their votes in the primary elections (primaries) in designated polling stations.

• Confirmed cases (symptomatic or asymptomatic) in isolation may vote in patient-designated polling stations

?

- Patients must travel in a private vehicle with complete separation between the front and back or in a private vehicle driven by the confirmed case alone without other passengers.
- Patients must go directly to the polling station and after casting their votes immediately go back to the isolation address.
- **Other people in isolation** must vote in a polling station designated for people in isolation.
 - People in isolation cannot use public transport, excluding taxis. If they travel in taxi, the person in isolation must mention to the taxi driver that they are in isolation; they must sit in the back with windows open.
 - People in isolation must go directly to the polling station and after casting their votes immediately go back to the isolation address.
 - If people in isolation arrive on foot, they must avoid standing next to other people, going through a public park, a bus station or any other place where they might have close contact with other people; they must avoid using elevators with other people, and avoid making non-essential stops.
- People in isolation who are not confirmed cases but have COVID-19 related symptoms (body temperature is 38 degrees Celsius or higher,

Permission for Confirmed Cases and People in Isolation to Go Outdoors to Cast their Votes in the Primary Elections (Primaries) cough, trouble breathing, or novel loss of smell or taste) must cast their votes in a polling station designated for confirmed cases, excluding:

- People in isolation who are symptomatic and have tested negative for coronavirus after the onset of symptoms must vote in a polling station designated for people in isolation.
- People in isolation due to fever of 38 degrees Celsius or higher or because a doctor referred them to do a coronavirus test and have not received the result yet, must cast their vote in a polling station designated for people in isolation
