Measures under the Communicable Diseases Act B.E. 2558 (2015) to control the Coronavirus Disease 2019 or COVID-19

Version 4 updated on 25 March 2020

1. By virtue of the provisions of Section 6 (1) of the Communicable Diseases Act B.E. 2558 (2015), the Minister of Public Health (MOPH) hereby declared coronavirus disease 2019 (COVID-19) as a dangerous communicable disease under the Communicable Diseases Act B.E. 2558 (2015) enforced since March 1, 2020. The declaration allows disease control officers in local areas to have the power to order or authorize others to bring the confirmed or suspected COVID-19 cases to be tested, treated, clinically diagnosed, isolated, quarantined, or controlled for observation until the lapse of the infectious period or until the situation has ended or any action under Section 34 of the Communicable Diseases Act B.E. 2558 (2015) on a case by case basis.

2.By virtue of the provisions of Section 8 of the Communicable Diseases Act B.E. 2558 (2015), the Minister of Public Health announced the Republic of Korea, the People's Republic of China, including Macau and Hong Kong Special Administrative Regions, the Republic of Italy, and the Islamic Republic of Iran to be defined as Disease Infected Zones of the dangerous communicable disease outside the Kingdom of Thailand under the Communicable Diseases Act B.E. 2558 (2015) enforced since 6 March 2020.

The announcement allows the disease control officers at quarantine offices to order or authorize others to direct the vehicle owners or vehicle controllers (any conveyance by land, air, or sea) from the four Disease Infected Zones entering the Kingdom of Thailand to bring passengers traveling in those vehicles to be checked by medical practitioners for possible isolation, quarantine or control for observation at designated areas for a designated period of time or to prohibit entry/exit of anyone from that vehicle unless approved by the disease control officers at the quarantine offices or any action under Section 40 of the Communicable Diseases Act B.E. 2558 (2015) on a case by case basis. Moreover, the Disease Infected Zones of the dangerous communicable disease outside the Kingdom of Thailand can be amended when the situation has ended or on a case by case basis.

- 3. According to the Department of Disease Control (MOPH) COVID-19 website, there are several countries, territories or areas with reported confirmed cases of COVID-19. The Department of Disease Control has alerted Thai people to refrain from unnecessary travel to those areas, through the Department of Disease Control website. For all travelers returning from the said areas, they must pass the screening procedures at airports and follow the instructions and recommendations to comply with Ministry of Public Health measures.
- 4. All passengers traveling into the Kingdom of Thailand may be subject to isolation, quarantine, under observation, or any other measures for the prevention and control of communicable diseases as prescribed by the communicable disease control officials at the international communicable disease control checkpoint.



Essential travel documents all passengers must carry

Before check-in at the airport of origin, the traveler must show the documents to the airlines including:

Non-Thai citizens

- Health certification describing that the passenger has no laboratory evidence of COVID-19 (SARS-CoV-2 infection), issued no more than 72 hours prior to the departure date.
- Health insurance that shows minimum medical coverage of least 100,000 USD that should cover all expenditures of medical treatment, including COVID-19, while traveling in Thailand. The traveler needs to purchase health insurance before traveling. This does not apply to Thai citizens and people already covered under the Thai government health insurance plan, who must provide their social security card.

Thai citizens

- Health certificate confirming that the passenger is fit to fly.
- Letter issued by the Royal Thai Embassy, Royal Thai Consular Office, or the Ministry of Foreign Affairs certifying that the passenger is a Thai national returning to Thailand.

If the passengers are unable to present the required documentation, the air operator shall not issue a boarding pass and the passenger will be denied of departure.

Upon arrival to Thailand, all passengers must comply with the following procedures:

- All travelers will pass a fever screening through a thermal scan. Travelers who meet the criteria of surveillance will be referred to a designated hospital.
- Travelers with fever and at least one of the following symptoms: runny nose, sore throat, and difficulty breathing, must notify the disease control officers at the disease control office immediately upon arrival in Thailand.
- People arriving in Thailand must fill in the health form (T.8 form) accurately and truthfully. The T.8 form must be submitted to the communicable disease control officials at the international communicable disease control checkpoint of the airport of disembarkation. Passengers may also enter their information in the "AOT Airport of Thailand" mobile application.
- Passengers have to download the "AOT Airport of Thailand" mobile application (by scanning the QR Code upon arrival or downloading it from the Google Play Store or the App Store prior to arrival) to record their information and monitor their health signs and symptoms until completing the duration of quarantine or self-monitoring period.



- 4.1 In addition to the requirements for all travelers, a traveler arriving from a territory outside the Kingdom of Thailand defined as a <u>Disease Infected Zone</u> of the dangerous communicable disease, must also implement the following:
 - All travelers who pass the initial fever screening must implement mandatory selfquarantine for 14 days at their registered hotels/accommodations and comply with the recommendations
 - In the case of foreigners, they must implement self-quarantine at the registered hotels, condominium, or dormitories, in which a Proof-of-Address document in Thailand for at least 14 days can be provided to the disease control officers at the disease control office.
 - In the case of Thai citizens, they must implement self-quarantine at his/her residence or designated areas (as determined by the Thai government), in which a Proof-of-Address document in Thailand can be provided to the officers.
 - None of these people are allowed to leave their quarantine areas until completing the duration of 14 days or until the lapse of the infectious period.
 - The aforementioned people must record their location with the disease control officers in the required channel of communication.
 - If those travelers exhibit clinical symptoms, they have to report the disease control officers within three hours.
- Examples of the Proof-of-Address for quarantine or control for observation document in Thailand for at least 14 days include: Reservation confirmations, or a copy of the person's address from the Ministry of Interior has to be provided to the disease control officers at the disease control office.
 - 4.2 In addition to the requirements for all travelers, a traveler arriving from an area with **Local Transmission according to the WHO**, must also implement the following:
 - All travelers who pass the initial fever screening are requested to implement control for observation (or self-monitoring) for 14 days at their registered residences and comply with the recommendations.
 - In the case of foreigners, they are requested to implement self-monitoring at the registered hotels, condominium, or dormitories, in which a Proof-of-Address document in Thailand for at last 14 days can be provided to the disease control officers at the disease control office.
 - In the case of Thai people, they are requested to implement self-monitoring at his/her residence or designated areas (as determined by Thai government), in which a Proof-of-Address document in Thailand can be provided to the officers.
 - The aforementioned people must record their location with the disease control officers in the required channel of communication



- If those travelers exhibit clinical symptoms, they have to report the disease control officers within three hours.
- They are requested to notify the disease control officers to ask permission to leave their hotels/residences and permission will be granted when deemed necessary via the required channel of communication.
- Examples of the Proof-of-Address for quarantine or control for observation document in Thailand for at least 14 days include: Reservation confirmations, or a copy of the person's address from the Ministry of Interior has to be provided to the disease control officers at the disease control office.
- 4.3 In addition to the requirements for all travelers, a traveler arriving from <u>Other Areas</u> not specified in 4.1 and 4.2 should do the following:
 - The travelers should take care of themselves with good sanitation, self-protection, avoid crowded places, eat cooked food, use serving spoons, wash hands and wear cloth masks. While coughing or sneezing, cover your mouth and nose in the appropriate way.

4.4 Transit passengers

*Temporary Special Exemption: Foreign passengers transiting through Thailand to another country (with a transit time of no more than 24 hours) need to implement the following:

- o Provide a Health Certificate prior to boarding at airport of origin, confirming that the passenger is **fit to fly**. The certificate must be <u>issued no more than 72</u> hours prior to the departure date.
- Pass through a thermal scan upon arrival to Thailand and pass through a thermal scan prior to departure from Thailand.
- These passengers are required to remain in the designated transit areas and strictly comply with the disease control measures applicable at the airport of transit in Thailand.
- * The exemption for foreign will be effective only until 31 March 2020, 23.59 Thailand local time. After this date, transit passengers will be required to present all documents as detailed in "Essential travel documents all passengers must carry"
 - Passengers who come from or who <u>transit through Disease Infected Zones</u> of the dangerous communicable disease outside the Kingdom of Thailand for any amount of time en route to Thailand, will need to follow the instructions as mentioned in 4.1.
 - Passengers who <u>transit through areas with local transmission</u> for any amount of time en route to Thailand, will need to follow the instructions as mentioned in 4.2. If the airport of origin is in a Disease Infected Zone, they must observe the protocol in 4.1 regardless of the transit airport.
