U-Pick Farm Guidelines

U-Pick operations are permitted to open safely. Core measures for all businesses, services and organizations Develop and follow an operational plan detailing methods to mitigate transmission of disease. Take every reasonable step to ensure physical...

Unlicensed Child Care Centres Guidance

An unlicensed child care centre will be required to close if either a child or the child care provider tests positive for coronavirus (COVID-19), or any other imminent health hazard, at the discretion of a public health official. Unlicensed child care...

Wearing Non-Medical Masks in the Community


