## **EXTRAORDINARY MEASURE**

The Ministry of Health, as the competent administrative authority pursuant to Section 80(1)(g) of Act No. 258/2000 Coll., on Public Health Protection and the amendment to certain related acts, as amended (hereinafter referred to as "Act No. 258/2000 Coll."), **orders** this extraordinary measure, proceeding pursuant to Section 69(1)(b) and (2) of Act No. 258/2000 Coll., in order to protect the population and prevent the occurrence and spread of the COVID-19 disease caused by the new SARS-CoV-2 coronavirus:

Ι.

Effective from 12:00 a.m. on 19 June 2020 until 11:59 p.m. on 21 June 23:59, celebrations, theater and film performances, sports and other gatherings and markets are prohibited or restricted, in that

- I. theatre, music, film, and other artistic performances, sports, cultural, religious, association, dance, traditional, and other similar events and other gatherings, exhibitions, festivals, funfairs, shows, tastings, markets, and fairs, educational events, celebrations, both public and private, attended by more than 500 persons at any one time, are prohibited; this prohibition does not apply to:
- a) meetings, congresses and similar events of constitutional bodies, public authorities, courts and other public authorities which are held on the basis of the law,
- b) gatherings pursuant to Act No. 84/1990 Coll., as amended, on the right to gather,
- c) to large events held in structurally partitioned compounds (sports stadium, exhibition grounds, etc.), at which the presence of more than 500 persons at any one time in each of the structurally separated sectors of the compound is prohibited, given that the entire compound is divided into maximally five structurally-partitioned sectors, each of which has access from the outdoors and the attendees are unable to move between the sectors; the distance between persons in neighbouring sectors must be at least 4 meters; in the case of premises with seating (e.g. sports stadium stands, etc.), seating is restricted so that the attendees of the large event may be seated only in every second row, and may be seated in such a row only if they are separated from other attendees by at least one empty seat,

## II. The following is restricted:

a) The holding of large events indoors, in that the following rules must be observed:

- a distance of at least 2 meters is maintained between the persons and simultaneously the attendees at the large event wear protective respiratory equipment, which prevents the spreading of droplets, except for household members or close relatives (hereinafter referred to as "household members"); in the case of participants in acceptance examinations for university, the distance need not be maintained between persons, but if the participants in acceptance examinations for university are at a distance of less than 2 meters, they must wear protective respiratory equipment to prevent the spreading of droplets, except for household members,
- hand disinfectant will be available for the attendees.
- b) The holding of large events outdoors, in that the following rules must be observed:
  - a distance of at least 1.5 meters is maintained between persons, excluding household members.
  - if the attendees of the large event are at a distance of less than 1.5 meters, they
    must wear protective respiratory equipment to prevent the spread of droplets, with
    the exception of household members,
  - hand disinfectant will be available for the attendees.
- c) Organized training or matches of athletes at outdoor and indoor sports grounds, so that the following rules are observed:
  - No more than 500 persons may be located on the sports grounds at the same time,
  - A distance of at least 2 meters is maintained between the athletes and other persons,
  - During training or matches, the athletes are not required to wear protective respiratory equipment (nose, mouth) which prevents the spread of droplets,
  - A container with disinfectant for the disinfection of the hands will be available on the sports grounds,
  - After the training or matches, all the used equipment will be disinfected regularly;
- d) Participation at wedding ceremonies, so that the following rules are observed:
  - It is attended by the fiancées, their two witnesses, the person acting on behalf of the public authority or person acting on behalf of the authorized church, registrar and other persons, so that the total number of attendees does not exceed 500 persons,
  - The participants in the wedding ceremony are not obliged to maintain a distance of at least 2 meters from other persons,
  - Upon conclusion of the wedding ceremony, all of the used items will be disinfected,
     These rules will apply mutatis mutandis to the declaration of persons that they are entering into a registered partnership together.
- e) Participation at church services, so that the following rules are observed:
  - the service is attended by at most 500 people at the same time,
  - the participants at the mass mandatorily disinfect their hands before entering the premises of the mass,
  - the participants at the service wear protective respiratory equipment (nose, mouth), which prevents the spread of droplets, except when taking the Eucharist/communion,
  - the wish of peace and blessing with holy water and similar rituals are omitted during the mass
  - the clergyman disinfects his hands at least before the start of the mass, before and after serving the Eucharist/communion,
  - the length of the mass is not needlessly extended while observing liturgical regulations,
  - the premises of the mass is duly ventilated and contact points (handles, pews, etc.) are disinfected after the mass,
  - The worshipers are prevented from entering other places in the church/choir except for the primary area of the service;

The same rules shall also apply to weddings and christenings; churches/choirs remain

open outside of mass for private prayer and individual spiritual care.

II.

Effective from 12:00 a.m. on 19 June 2020, the extraordinary measure of 12 June 2020, Ref. No. MZDR 20588/2020-7/MIN/KAN, is repealed.

III.

This extraordinary measure takes effect on the date it is issued.
