## Health Alert: Mali, COVID-19 Update and Reopening of International Airport

Location: Mali

**Event:** Ongoing COVID-19 Response

The Government of Mali has announced that as of July 28, 2020 there are 2,520 confirmed cases of COVID-19 in Mali, including 124 deaths and 1,919 recoveries.

The government announced the resumption of commercial air travel effective July 25, 2020 and the reopening of land borders to passenger traffic on July 31, 2020. The Government of Mali has implemented enhanced screening and quarantine measures to reduce the spread of COVID-19. Travelers should be prepared for additional travel restrictions to go into effect with little or no advanced notice.

Incoming air travelers will be required to:

- · Wear a mask.
- Complete a form with contact information, travel history and health symptoms. The form is available online at <a href="https://www.sante.gov.ml">www.sante.gov.ml</a> and <a href="https://www.sante.gov.ml">www.sante.gov.ml</a>
- · Present a negative COVID-19 test taken no more than 72 hours prior to arrival in Mali.

Any person suspected of having COVID-19 will be isolated at the airport and a COVID-19 test will be conducted. If test results are positive, that person's travel documents will be retained, and the traveler will be put into isolation at a government of Mali facility. The travel documents will be returned once the patient is deemed COVID-19-free through subsequent testing.

Incoming passengers at the land points of entry will be required to present a negative COVID-19 test taken no more than 72 hours prior to arrival at the border. Any person suspected of having COVID-19 will be isolated at the border and a COVID-19 test will be conducted.

The Government of Mali has taken the following additional steps to reduce the spread of COVID-19:

- · Face masks are mandatory in public.
- Schools and universities have allowed students with mandatory exams to return, but schools remain closed to most students.
- Sporting events, festivals, and gatherings larger than 50 people have been banned, and bars and night clubs have also been closed.
- · Vehicle occupancy has been restricted to promote social distancing.
- · The General Directorate for Commerce and Competition set price limits for essential goods, including sugar, rice, cooking oil, and bread.

The work schedule for all government offices (with the exception of defense, security, and health) has been reduced to 7:30 a.m. to 2:00 p.m. Monday through Friday until August 1, 2020.
