2 - Availability of basic necessities

It has been observed, during this period of the coronavirus pandemic (COVID-19), that certain economic operators engage in speculation on the prices of essential products or sometimes refuse to sell certain items, in particular:

- Milk,
- rice,
- wheat flour,
- vegetable oils,
- tomato concentrates,
- sugar,
- household soap,
- pasta,
- hydroalcoholic gel,
- protective masks and gloves, etc.

These practices, which create artificial shortages in the markets, are contrary to the provisions of Articles 13 and 18 of Law No. 99-011 of December 28, 1999 relating to competition in Togo.

In addition, the Government reminds owners of supermarkets, convenience stores, shops and pharmacies to respect barrier measures, in particular the safe distance, hand washing, limiting the number of customers and controlling the temperature at the entrance.

The Government appeals to everyone's conscience for strict compliance with VIRUS IN TOGO (HTTPS://COV these provisions in these difficult times and informs economic operators that unannounced checks of trade inspectors, health workers and law enforcement officials will be carried out on the premises. entire territory as of this day.

Any offender will be severely punished in accordance with the laws in force.
