Obtain a health pass in the event of vaccination abroad

Since August 9, 2021, the health pass is mandatory in certain places to minimize the risk of contamination by the Covid-19 virus and applies from the age of 12 throughout France.

How to obtain a health pass in case of vaccination abroad?

The health pass consists of the presentation, digital or paper, of a vaccination certificate (on condition of having a complete vaccination schedule with one of the vaccines recognized by the European Medicines Agency or equivalent to these vaccines), a test or reinstatement certificate. In order to allow nationals of a country outside the European Union visiting France to claim their vaccination to access activities and places subject to the pass, pharmacists can now issue a certificate of vaccine equivalence valid as a health pass.

Who can request a certificate of vaccine equivalence?

To obtain a certificate of vaccine equivalence valid as a health pass, the conditions to be respected are the following:


• Not to have been vaccinated in one of the following countries: Member States of the European Union, Albania, Andorra, Armenia, islands Faroe Islands, Iceland, Israel, Liechtenstein, North Macedonia, Morocco, Monaco, Norway, Panama, United Kingdom, San Marino, Switzerland, Turkey, Ukraine, Vatican. These countries allow obtaining the digital COVID certificate from the EU or equivalent, which is accepted in France.



These essential documents must clearly include the surname, first name, date of birth as well as the date of vaccination, the vaccine used, if possible its batch number, the number of doses injected and the country of vaccination.

How much does it cost to generate a certificate of vaccine equivalence?

The vaccine equivalence certificate generation service may be invoiced for a price not exceeding € 36 including tax.

How to keep the certificate of vaccine equivalence?

The certificate can be stored indefinitely in <u>TousAntiCovid</u> to be presented in places subject to the health pass. To do this, simply download the application and then scan the QR Code to import it. It is also possible to take a photo of the certificate of vaccine equivalence generated by the pharmacist to keep a digital copy.
