{Taking into account the epidemic situation in the region from December 19, 2020 to August 31, 2021, quarantine was established on the territory of Ukraine in accordance with the Resolutions of the Cabinet of Ministers № 392 of 20.05.2020 , № 500 of 17.06.2020 , № 641 of 22.07.2020 , № 760 from 26.08.2020 , № 956 from 13.10.2020 , № 1100 from 11.11.2020 , № 1236 from 09.12.2020 , № 104 from 17.02.2021 , № 405 from 21.04.2021 , № 611 from 16.06.2021 }

Pursuant to Article 29 of the Law of Ukraine “On Protection of the Population from Infectious Diseases” in order to prevent the spread of acute respiratory disease COVID-19 caused by coronavirus SARS-CoV-2 (hereinafter - COVID-19), taking into account the decision of the State Commission of technogenic and ecological safety and emergencies of March 10, 2020. The Cabinet of Ministers of Ukraine resolves:

1. Establish quarantine from March 12, 2020 to May 22, 2020 throughout Ukraine.
