



RESOLUTION
of the Verkhovna Rada of Ukraine

**On additional measures to combat the spread of coronavirus
disease (COVID-19)**

Given the aggravation of the epidemic situation due to the rapid spread of acute respiratory disease COVID-19 caused by the coronavirus SARS-CoV-2 (hereinafter - COVID-19), and to minimize the negative effects of the epidemic COVID-19 for a single legislature :

1. In addition to the conditions of admission established to ensure the legal regime of state protection of administrative buildings, structures and office premises of the Verkhovna Rada of Ukraine, establish that for the period of quarantine established by the Cabinet of Ministers of Ukraine to prevent the spread of COVID-19 in Ukraine, admission to the premises of the Verkhovna Rada of Ukraine of People's Deputies of Ukraine of the current convocation of the Verkhovna Rada of Ukraine, people's deputies of Ukraine enterprises and institutions that support the activities of the Verkhovna Rada of Ukraine, assistants-consultants of people's deputies of Ukraine, members of the Cabinet of Ministers of Ukraine, representatives of central executive bodies, officials of other state authorities and representatives of local governments, scientists, experts, practitioners, representatives the public, the media and other persons is allowed in the presence of one of the following documents:

a document confirming vaccination against COVID-19 with one or more doses of vaccines included in the World Health Organization in the list of permitted for use in emergencies, issued in accordance with the International Health Regulations (2005) or in accordance with international agreements concluded by Ukraine on mutual recognition of vaccination documents from COVID-19 - for adults;

a foreign COVID certificate confirming vaccination against COVID-19 with one or more doses of vaccines included in the World Health Organization in the list of permitted for use in emergencies;

negative result of testing for COVID-19 by polymerase chain reaction (PCR test), conducted not more than 72 hours before the presentation of the document, or rapid test for coronavirus antigen SARS-CoV-2, conducted not more than 48 hours before the presentation of the document - for persons 7 years and older;

Certificate of recovery of a person from COVID-19, if the person fell ill no more than 6 months before the presentation of the document - for persons from 7 years and older.

2. The staff of the Verkhovna Rada of Ukraine to provide:

1) preparation of draft regulations necessary for the implementation of measures provided for in this Resolution;

2) equipping security posts through which persons are admitted to administrative buildings of the Verkhovna Rada of Ukraine with appropriate technical means to meet the conditions of admission provided for in this Resolution;

3) інформування осіб, зазначених в абзаці першому пункту 1 цієї Постанови, про встановлені цією Постановою додаткові умови допуску до адміністративних будинків Верховної Ради України;

4) облаштування в адміністративних будинках Верховної Ради України пунктів вакцинації проти COVID-19 для щеплення бажаючих осіб у тижні, відведені для пленарних засідань Верховної Ради України.

3. Ця Постанова набирає чинності з дня, наступного за днем її опублікування, крім пункту 1, який набирає чинності після виконання Апаратом Верховної Ради України вимог пункту 2 цієї Постанови, але не пізніше 15 листопада 2021 року.
