BE IT ENACTED, by and with the advice and consent of the House of Representatives and Senate of Belize and by the authority of the same, as follows:

(b) medical officers of health;

- (c) a Principal Health Inspector and such other public health inspectors as may be necessary; and

CAP. 39. (2) A Medical Officer appointed under the Medical Service and Institutions Act shall be a health officer for Belize, unless provided otherwise under any law.".
