

Declaration of Public Health Emergency (Amendment) Order No. 48 of 2022

In exercise of the powers conferred on me by section 21A of the Public Health Act [CAP 234], I, the Honourable BRUNO LEIGNKONE, Minister of Health, on the recommendation of the Committee, make the following Order.

1 Amendments

The Declaration of Public Health Emergency Order No. 6 of 2022 is amended as set out in the Schedule.

2 Commencement

This Order commences on the day on which it is made.

SCHEDULE

AMENDMENTS OF DECLARATION OF PUBLIC HEALTH EMERGENCY ORDER NO. 6 OF 2022

1 Clause 3A

Repeal the clause, substitute

“3A Conditions relating to inbound and outbound travelling

- (1) A person travelling out of Efate or Santo either by sea or by air must comply with the traveller’s guide and Standard Operating Procedures for Sea Ports and the Civil Aviation Authority.
- (2) Subject to subclause (3), any international travelling into Vanuatu by sea or air is prohibited.
- (3) The Health Emergency Advisory Committee may approve an inbound travelling after it has considered a traveller’s reason for inbound travelling.”

2 Subclause 3AB (1)

Repeal the subclause, substitute

- “(1) A curfew is applied throughout Vanuatu from 6pm to 6am from the date on which this Order is made and ceases to have effect at 6am on Friday 08 April 2022.”






