Decree 117/2021, of 14-4-2021 amending and extending Decree 93/2021, of 24-3-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-coronavirus 2.

Statement of reasons

Keeping the current measures in place has allowed the curve of the fourth wave to begin to bend, as the number of infections is falling and hospital pressure is being maintained.

For this reason, it has been thought appropriate that in certain institutional events the maximum number of people per table is eliminated to the extent that the specific protocols previously approved by the Ministry of Health allow it.

For everything that has been presented, at the proposal of the Minister of Health, the Government, in the session of April 14, 2021, approves this Decree with the following content:

Article 1

Modification of the first section of article 10 of [Decree 93/2021](#) , of 24-3-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus

The first paragraph of article 10 of [Decree 93/2021](#) , of 24-3-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus, entitled "General measures of hygiene and prevention in catering establishments" , which is drafted with the following content:

"Article 10. General hygiene and prevention measures in catering establishments

The maximum number of people who can be grouped per table in restaurants is two, unless it is a higher cohabiting group, understanding that the cohabiting group is made up of the parents and their minor sons and daughters, or adults with disabilities, and who habitually and permanently live in the same home. The number of people can be increased to a maximum of four on the outdoor terraces and inside the premises during lunch and dinner, between 11:30 and 16:00 and 19:00 and 24:00. Otherwise, the number of people can be

increased in meals of an institutional nature, as long as there is a specific protocol previously approved by the Ministry of Health.

Likewise, inside bars, cafes and similar establishments, the number of people per table during the breakfast time slot , from 7 am to 11.30 am or 12 pm, can be four."

Article 2. Extension of the exceptional measures of [Decree 93/2021](#) , of 24-3-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus

[Decree 93/2021](#) , of 24-3-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus, is extended until April 21, 2021 , with the modifications approved by [Decree 100/2021](#) , dated 3-31-2021.

Final provision

This Decree enters into force on April 15, 2021.
