### Ministerial order

Ministerial order of 14-4-2021 relating to the call and publication of the rules for the Andorra 2021 national fair for males of the brown race.

### Statement of reasons

Given that in 2019 the 8th National Fair for males of the brown race of Andorra was held;

Given that in 2020 the Men's Fair was canceled due to the epidemiological and health situation caused by the SARS-CoV-2 coronavirus;

Given article 16 of the Government Law, of December 15, 2000;

The Minister of Environment, Agriculture and Sustainability, by virtue of the powers assigned to him by law,

It has

### Article 1

Convene the 9th national competition for Andorran brown males, which will take place on Saturday 8 May 2021 in Ordino, in the Tanada field, as part of the Livestock Fair organized by the Municipality of Ordino .

### Article 2

Publish the rules that will govern the competition fair (see the attached document).

### Final provision

This ministerial order will enter into force the day after it is published in the Official Gazette of the Principality of Andorra .

Bases Fira National Contest for Males of the Brown Breed of Andorra 2021

### Chapter 1. Date

### Article 1

The Fira competition for males of the brown breed of Andorra, organized by the Department of Agriculture, under the presidency of its minister, and with the collaboration of the Association of Farmers and Ranchers, will take place on Saturday, May 8 in Order

## Chapter 2. Participation and exhibition conditions

### Article 2

The competition is open to all breeders or groups of breeders in the Valls d'Andorra who present animals with the following characteristics:

9th National Competition for Males of the Brown Race of Andorra

1st section - Males from 12 to 30 months

2nd section - Males over 30 months

Note: to be able to participate, the animals must be registered in the Program of genetic selection of the brown breed of Andorra.

### Article 3

The section that does not have the participation of a minimum of three heads of cattle from two different owners will be deserted.

### Article 4

Participating animals must have been born in the Principality. The competing owner must have registered them at least one month before the celebration of the Fair. The origin of the animals is checked (by means of the individual files).

### Article 5

Participating livestock owners must be recognized and admitted by the Organizing Committee.

The participation of animals that have been in the Vilanova del Pariatge genetic selection center during 2021 is not accepted.

### Article 6

The animals present at the Fair can be sold on the premises of the same event.

## Chapter 3. Health conditions

### Article 7

The animals must be registered in the padral, in a herd qualified as officially free of tuberculosis, brucellosis and enzootic bovine leukosis.

## Chapter 4. Awards

### Article 8

The following prizes will be awarded for each animal section:

1st prize 240 euros

2nd prize 120 euros

3rd prize 90 euros

## Article 9

Participation in the Fira concurso is premium as follows: 46.20 euros per head of cattle up to the amount of four heads of cattle (that is, 184.80 euros for the farmer who has more than three heads).

## Chapter 5. Transport

### Article 10

The transport of the participating animals from the court or farm to the site of the Fair is the responsibility of the owner of the livestock.

## Chapter 6. Declaration

### Article 11

To participate or exhibit in this competition Fair, the interested person must send a duly signed registration request to the Department of Agriculture, before Wednesday, May 5, 2021. You must attach the corresponding individual files.

These applications can be collected from the Department of Agriculture, Carrer de la Grau, Prat del Rull building, first floor.

### Article 12

Any statement sent after the date set in article 11, as well as any illegible or incomplete statement, is considered null and void.

### Article 13

Competitors are responsible for their declarations and in particular for indicating the sections in which their animals must compete.

The Organizing Committee excludes from the competition the animals for which this indication is deliberately wrong.

## Chapter 7. Reception of animals

### Article 14

Animals must be provided with two strong, long ropes in good condition. Cattle must wear, if necessary, a nose ring.

The arrival of the animals takes place at 8 o'clock. Animals must be placed at 9 o'clock.

## Chapter 8. Jury

### Article 15

The Jury is made up of the following members:

- A veterinarian from the Department of Agriculture who participates in the genetic selection program for the Andorran brown breed;
- A technician accredited by the Department of Agriculture;
- A technician from Groupe Gascon, advisory body for the genetic selection program for the Andorran brown race;
- A technician from the Brown Race Federation of the Pyrenees.
