Decree 168/2021, of May 26, 2021

Decree 168/2021, of 26-5-2021, amending and extending Decree 133/2021, of 28-4-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV coronavirus -2.

Statement of reasons

The continued downward trend in pandemic indicators, favored by the good pace of vaccinations, allows some restrictions to continue to be relaxed. In this way, the number of attendees allowed at the celebrations provided for in section 10 of article 10 of Decree 133/2021 - which was already modified by Decree 147/2021, of 12-5-2021, is increased -. In the future and exceptionally, beyond 40 attendees inside the premises and 100 outdoors, up to 100 people can gather inside - as long as 50% of the capacity of the premises is not exceeded - and up to 200 in outdoor spaces, with the understanding that a specific protocol will be required. The protocol can also allow to extend the number of people per table and the lunch schedule.

Otherwise, the rest of the measures remain in force and Decree 133/2021, of 4-28-2021, is extended again until next June 2.

For everything that has been presented, at the proposal of the Minister of Health, the Government, in the session of May 26, 2021, approves this Decree with the following content:

Article 1

Paragraph 10 of article 10 of Decree 133/2021, of 28-4-2021, of new exceptional measures due to the evolution of the health emergency caused by the SARS-CoV-2 coronavirus, titled Measures, is amended general rules for hygiene and prevention in catering establishments – already modified by Decree 147/2021, of 12-5-2021–, which is drafted with the following content:

"10. The premises and dining rooms, as well as terraces or outdoor spaces where meals are offered for celebrations such as baptisms, birthdays, communions, weddings and other social events, can accommodate a maximum number of attendees of 40 people in interior

spaces, without exceed 50% of the venue's maximum capacity, and up to 100 people in outdoor spaces. Up to 100 people can be accommodated in indoor spaces when 50% of the venue's maximum capacity is not exceeded, and it can be expanded to a maximum of 200 attendees in outdoor spaces. In both cases it is necessary to have a specific protocol validated by the health authority that incorporates screening to identify people with SARS-CoV-2 infection. Otherwise, and subject to protocol validation, the maximum number of people per table can also be extended to 10 and lunch hours can be extended until 6pm. No dancing activities can be carried out and any consumption of food and drinks must be done while sitting at the table."

Article 2

Decree 133/2021, of 28-4-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus, with the modifications introduced, is extended until June 2, 2021 by decrees 142/2021, of 5-5-2021; 147/2021, of 12-5-2021, and 158/2021, of 19-5-2021.

Final provision

This Decree enters into force on May 27, 2021.
