Decree 347/2021, of October 27, 2021

Decree 347/2021, of 27-10-2021, extending and amending Decree 333/2021, of 13-10-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS coronavirus- CoV-2.

Statement of reasons

The sanitary and epidemiological situation remains stable compared to the previous week, so it is necessary to maintain the same preventive measures established until now.

In this context, the extension of the measures adopted by [Decree 333/2021](#) , of 13-10-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus for a another week

It is also expected that the extension for one more week of the exercise of the disco activity with the measures provided for in the Decree and in the framework of the ongoing observational study, as well as establishments with pub activity, lounges dancing or similar with the application of the same measures as in establishments with disco activity.

For everything that has been presented, at the proposal of the Minister of Health, the Government, in the session of October 27, 2021, approves this Decree with the following content:

Article 1. Amendment of Decree 333/2021, of 13-10-2021

Paragraph 1, letter a, of article 9 of [Decree 333/2021](#) , of 13-10-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus is modified 2, which is drafted with the following content:

"Article 9. General measures of hygiene and prevention in establishments with disco activities

1. In nightclubs, and as part of the ongoing observational study to find out the possible transmission of the virus in these spaces, the exercise of this activity is authorized under the conditions set out below:

- a) Authorized establishments may open from Friday to Sunday (inclusive) during the validity of this Decree.
- b) Closing time is at most three in the morning.
- c) The establishments must have a capacity limited to 70% of the total.
- d) The use of the mask is not mandatory inside the premises.
- e) The establishments are obliged to carry out an access control to ensure that the attendees certify that they meet one of the following conditions:
 - i) Be vaccinated against COVID-19 and fourteen calendar days have passed since the date of administration of the last dose of the complete vaccination schedule.
 - ii) Having passed the illness in less than six months.
 - iii) Have a negative diagnostic test for SARS-CoV-2 infection (PCR or TMA done in the previous 48 hours).
- f) Establishments must ensure adequate ventilation of the space taking into account what is provided for in article 1, section 9.
- g) Access to these establishments is limited to people over the age of eighteen.

2. Establishments with pub, dance hall or similar activities, within the framework of the ongoing observational study, may apply the same measures provided for establishments with disco activities (sections a, b, c, d , fig of section 1) and allow the dance activity, if they carry out the access control provided for in section e of this article."

Article 2. Extension of exceptional measures

[Decree 333/2021](#) , of 13-10-2021, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus, is extended until November 3, 2021 .

Final provision

This Decree enters into force on October 28, 2021.
