THE QUARANTINE ACT (COVID-19) (CHARGES FOR TESTING) REGULATIONS, 2021, made by the Cabinet by virtue of the powers contained in section 4 of the Quarantine Act, Cap. 361

1. Citation and commencement

(1) This Order may be cited as Quarantine Act (Covid-19) (Charges for Testing) Regulations, 2021 in Antigua and Barbuda.

(2) This Order shall be deemed to have come into effect on the 14th day of May, 2021.

2. Fees for Testing

(1) Subject to subregulation (2), persons arriving in or leaving from Antigua and Barbuda who are required to be tested for COVID-19 may be tested at the Mount St. John's Medical Centre on payment of a fee as outlined in Part A of the Schedule of Fees.

(2) For a fully vaccinated person who desires to have his or her quarantine period reduce from 14 to 7 days pursuant to the guidelines issued by the Quarantine Authority, testing may be done through the Mount St. John's Medical Centre on payment of a Fee as outlined in Part B of the Schedule of Fees.

3. Civil Debt

All unpaid charges levied against a person under this regulation may be sued for and be recovered on behalf of the Crown as a civil debt owed to the Crown.
